Rental Assistance in the Daytona Beach Area

[Volusia County Human Services \(VCHS\), 250 N. Beach Street \(386\) 254-4675](#)

Go to VCHS on a Tuesday or Thursday for rental assistance. VCHS first opens its doors at 8 a.m. but people come early. No line is formed until the doors open. Everybody in line signs the sign-up sheet. If you or a household member receives disability income, or are elderly (age 62), or have small children (up to age 5), then be sure to check the appropriate box on the sign-up sheet.

You will need to take a photo ID, a social security card for all members of the household, proof of income for the last 90 days, your current lease or rental agreement, proof of any payments to the landlord for the last 60 days, and an eviction notice.

You may receive a portion or all of your rent paid by VCHS. You may be denied rental assistance. If your application for assistance is denied, you will receive a letter from the caseworker. It is important that you keep this letter of denial. You may also write to the supervisor if you think you were wrongly denied.

If you are in need of other assistance, for example, to help pay your utilities, go to VCHS on a Monday, Wednesday or Friday.

If, for any reason, you are denied assistance by Volusia County Human Services (VCHS), or you need additional rental assistance, you should make an appointment with HUM. HUM will require the VCHS denial letter or proof of the portion of rent VCHS will pay.

HUM prefers that you call to schedule an appointment. New appointments are only scheduled for the current month. For example, if you call in January, you will not be able to schedule an appointment in February. Appointments are scheduled quickly, so call as soon as you can at the beginning of the month.

If the month is already booked with scheduled appointments, ask for your name to be put on the waiting list. If there is a cancellation or a no show, then they might call you. Otherwise, you will need to try again at the beginning of the next month to schedule an appointment.
