



LETTER FROM THE CEO



I continue to remain both proud and humbled by the impact our dedicated lawyers, staff, and volunteers make in Central Florida every day. In early 2020, Community Legal was able to quickly pivot our operation by leveraging our historical investments in technology to a completely remote workforce in order to remain effective despite the pandemic. We had no downtime in services as a result of this transition, and while many organizations saw a significant reduction in community impact as a result of the pandemic, Community Legal only saw a less than 3% decrease in the number of people we served. Now that offices have reopened for staff and we can assist clients on an appointment only basis, we are perfectly situated to make 2021 our most impactful year ever.

Our success, in part, is due to the tremendous support we received in 2020 from our community. In 2020, we saw record numbers of attorneys participating in legal advice clinics, and a significant increase in funding from donors and community partners. We have used this opportunity to build stronger relationships with our local and state officials as we work together to address those secondary disasters attributable to the pandemic, including families losing jobs and on the verge of becoming homeless.

As you take some time to review our accomplishments from last year, consider reaching out to take a case, make a contribution, or both. I know that the community still needs our help more than ever, and we certainly could use yours.



Jennifer (Medical Legal Partnership)

Jennifer has numerous medical issues, was homeless, staying in a shelter, and was hospitalized multiple times before being referred to CLSMF through the Medical Legal Partnership (MLP) with Grace Medical Home. Thanks to the swift and dedicated efforts in September 2019 by the MLP team, the Social Security Administration approved ongoing and retroactive benefits by January 2020. Jennifer is extremely grateful to CLSMF for working so quickly to help her receive income and medical coverage, helping her maintain housing and stable living.

Leigh Ann (Family Law)

Leigh Ann is a 28-year-old single mom and victim of domestic violence. She was referred to CLSMF by the State Attorney's Office. The CLSMF Family Law unit filed and was granted an Injunction for Protection (IFP) on behalf of Leigh Ann. She also received an order granting 100% time-sharing of the children because the minor child witnessed the domestic violence. CLSMF is proud to work with victim advocates and community partners to keep everyone safe!




CLIENT STORIES

Danielle (Helpline)

Danielle came to us as a 19-year-old woman who did not have a proper birth certificate or identification. Although a resident of Florida now, her New York birth certificate simply stated "Baby Girl" as her name. Having gone by Danielle her entire life, she needed her legal documents to prove her identity. CLSMF helped her to obtain a legal name change; securing for her a State of Florida ID and a New York birth certificate. Danielle was able to vote for the first time in the recent Presidential election.





Fred (Helpline)

Fred is a 61-year-old Deland resident who had experienced five years of homelessness. CLSMF was able to help him apply for and receive Social Security Disability benefits, Section 8 Housing as well as Medicaid benefits. This client was grateful to have a home and medical treatment for the first time in years!
